Log Files

Software Business Solutions ('SoftwareBiz') follows a standard procedure of using log files. These files log visitors when they visit any of our domains. All hosting companies do this and a part of hosting services' analytics. The information collected by log files include internet protocol (IP) addresses, browser type, Internet Service Provider (ISP), date and time stamp. These are not linked to any information that is personally identifiable. The purpose of the information is for analyzing trends, administering the site, tracking users' movement on the website, and gathering demographic information for our user experience improvement program.

Cookies and Web Beacons

Like any other website, Software Business Solutions ('SoftwareBiz') uses 'cookies'. The information is used to optimize the users' experience by customizing our web page content based on visitors' browser type and/or other information.
